TITLE: Consideration of proposed projects for funding through continuation of specific purpose tax

ITEM: The purpose of the special meeting is to review, discuss and prioritize proposed eligible City of Laramie projects to be considered for inclusion on the county wide ballot for continuation of the specific purpose tax in May 2010.

The Council will review the projects proposed via public input received at the October 19, 2009 Town Hall Meeting, as well as proposed projects from Councilors and staff.

In addition, staff have arranged for Kaiser & Company of Cheyenne to be present on October 26th to answer any additional questions Council might have. Kaiser & Company will provide advice on tax ceiling projections; payback period; and, bonding alternatives and processes.

The prioritized list of proposed projects will then be available for the meeting planned on November 5, 2009 with the Albany County Commissioners and the Town of Rock River.

It is recommended that Council adopt a resolution acknowledging the priority list of proposed projects.
